It is the responsibility of ATAINZ Members to select professional development courses and activities that contribute towards their Continuing Professional Development (CPD) Hours.

These courses and activities are not restricted to those organised by ATAINZ nor are they restricted to accounting or taxation topics. Courses or activities should assist Members in their continuing professional development.

Continuing Professional Development is a combination of both Structured and Unstructured activities:

#### **Structured Activities:**

Structured activities includes both Informal and Formal activities:

- (a) Informal activities includes such things as:
  - Reading of technical or professional articles.
  - Viewing of the ATAINZ Ethics video.
  - Viewing of technical or professional articles on the internet.
  - Participating in mentoring or group discussions.
- (b) Formal activities include such things as attending organised or structured training or courses.

#### **Unstructured Activities:**

Unstructured is an activity that assists the Member grow as an individual, but does not involve structured study that relates to the Accountancy industry.

#### **Continuing Professional Development Hours Requirements:**

To meet ATAINZ Continuing Professional Development requirements, ATAINZ Members must obtain the following minimum Continued Professional Development (CPD) Hours over a 12 month period being from 1<sup>st</sup> January to 31<sup>st</sup> December.

#### (a) Professional Tax & Business Advisor (PTBA)

PTBA Members must obtain a minimum of **40** CPD Hours from the following activities:

- 10 Hours Informal (maximum)
- 30 Formal (minimum)
- 5 Unstructured (maximum)

#### (b) Registered Tax and Business Advisor (RTBA)

RTBA Members must obtain a minimum of **30** CPD Hours from the following activities:

- 10 Hours Informal (maximum)
- 25 Formal (minimum)
- 5 Unstructured (maximum)

### (c) Associate Tax & Business Advisor (ATBA)

ATBA Members must obtain a minimum of **25** CPD Hours from the following activities:

- 10 Hours Informal (maximum)
- 20 Formal (minimum)
- 5 Unstructured (maximum)

## **Retired & Academic Membership:**

There are no Continuing Professional Development requirements for Retired or Academic Members or those ATAINZ Members who are on approved Sabbatical Leave.

### Conference/Workshop LiveStream:

To qualify for LiveStream CPD Hours you must register for the Conference/Workshop. Should you choose to watch the LiveStream with other Members then only those who have registered will receive CPD Hours.

If a conference or course that you attended or completed is not on the above list please email ATAINZ (<a href="mailto:admin@atainz.co.nz">admin@atainz.co.nz</a>) to see if they are eligible for Continuing Professional Development Hours.

### Members who join ATAINZ during the Year

Members who join ATAINZ during the year will have a CPD Hour requirement prorated based on the number of months that they have been a member in the calendar year.

(ie: if you join in June that is 6 months, so  $6/12 \times 25 = 12.5$  CPD hours requirement).

## **Continuing Professional Development Hours Audits**

All ATAINZ Members will be subjected to random audits as regards their Continuing Professional Development Hours. These Audits will require confirmation of attendance at Formal Activities and proof of completion of Informal Activities.

Failure of a Member to obtain the required annual Continuing Professional Development Hours may result in their Membership to ATAINZ being suspended or terminated, subject to Board consideration.

## **RADAR Online Learning Platform**

ATAINZ offers an online learning platform known as "Radar" that in addition to providing valuable training resources is also your online CPD log.

You will have received an email from Strategi (<a href="mailto:support@strategi.ac.nz">support@strategi.ac.nz</a>) that will provide you with access to the Radar system. A Radar Quick User Guide is available for you to view on the ATAINZ website.

#### **Continuing Professional Development Hours Declaration**

Your Annual Continuing Professional Development Hours Declaration must be made via the Radar online platform by the 31<sup>st</sup> March for the previous years' declaration.

On the 1<sup>st</sup> January Continuing Professional Development Hours will "roll forward" to the current year to enable you to commence updating your current CPD Hours, however you will still be able to update your previous year's CPD record until the 31<sup>st</sup> March.
